1. Trail Name, Alene Woodeage

Bryan provided a brief introduction of the process and purpose for naming a trail facility, then introduced Alene Woodeage who presented her request to the Board.

Alene Woodeage of Ridgefield shared a brief biography of the person she wanted to name a trail after, John Hudson Senior. He was an incredible educator/principal for many years at Ridgefield in the late 1960s. As a child, he was brought up with strong work ethics. These values carried over to the school and students he taught. Amongst many accomplishments, he started the Cispus Outdoor School Program. This year marks its 48th anniversary. He was an extraordinary person, made numerous contributions to the community, an environmentalist and very supportive of the refuge. He deserves to have a trail named after him.

Marie opened the floor for public testimony or comments. Morine O'Riley, of Ridgefield, suggested naming the high school after John.

Public Works Update

Bryan provided an update on reconfiguration to the Ridgefield Outdoor Recreation Center (RORC). Modifications will save about 30% to the cost of dirt that won't have to be moved. The school has shifted south slightly which moves it further back from the road and allows a separate entrance for buses. The project should go out for bid around the end of June, awarded in July, begin grading in August and installation of utilities in the fall. Field construction would begin in spring of 2018. The goal is to have the fields ready for use when the school opens in 2018.

Another update include the Bear Dedication on Saturday, May 6, 2017, at 10am at Overlook Park. The ceremony is open to the public as part of the First Saturday festivities and Mayor Ron Onslow will say a few words.
